BABYDOLL SOUTHDOWN SHEEP RESERVATION FORM & PURCHASE CONTRACT

I agree to purchase the following SHEEP or LAMB(s) from:

NOTE: If reserving prior to lambing, this contract is subject to availability. Many times, I have repeat buyers requesting lambs unrelated to previously purchased lambs. I also allow my buyers to request lambs (not guaranteed) produced by a sire/dam combination (combinations are available for viewing on my website usually by October). Because of this, reservations are not necessarily filled in the order in which they are received. I retain the right to retain any lamb born for myself regardless of reservations received.

- 1) My deposit of \$270.00 PER SHEEP reserved is enclosed, **PLUS** \$30.00 PER SHEEP for the required Certificate of Veterinary Inspection for Livestock (CVI) required for both intrastate and interstate travel. Any fees for additional health tests required by a purchaser's state are their responsibility and must be paid in full before the testing is completed.

- 2) Sheep will be registered with the NABSSAR, excluding wethers. If you would like your sheep to be registered with the OEMBSSR, excluding wethers, if qualified, include an additional \$15.00 PER SHEEP at time of reserving and initial below.

- 3) If you would like your sheep to be RR at codon 171, include an additional \$50.00, PER SHEEP at time of reserving, and initial below.

I agree to the following payment plan:

Please accept my deposit. A check/cash payment of \$270.00 + \$30.00 + \$50.00 (if applicable, per sheep, for RR sheep) + \$15.00 (if applicable, per sheep, for OEMBSSR CoR) per sheep is enclosed (made payable to Bergamascos' Babydoll Brigade). Any discounts being applied will be deducted from the balance due or paid to buyer at pick-up.

If for any reason I decide at a later date not to purchase the reserved sheep or lamb(s), other than the instances listed below, my FULL deposit will be forfeited:

1. In the event lambs are reserved before birth, and there are not enough lambs born that season to fill a lamb reservation to meet my sex and/or genotype choice, my deposit on the lamb not filled in contract will be returned after all reserved lambs have been picked up by buyers.
2. In the event I reserve more than one lamb, the deposit on unfilled lambs can be applied to other lambs I am purchasing; or, the deposit can continue to be held on the unfilled lamb, at my written request, for the next season's lambs.
3. If the reserved animal that is being held for me should become unavailable due to illness, injury, death, or it was retained, I hold Bergamascos' Babydoll Brigade, LLC, and Michelle Schubert harmless, and understand my deposit and payments will be returned to me within 30 days of notification, or deposit can be retained by Bergamascos' Babydoll Brigade, LLC, for the next available sheep/lamb.

If you are picking up the sheep/lamb personally at my farm, I will provide you with a preferred pick-up date and time. If you have not confirmed with me within seven days after the date on the notification sent or worked out another date and time for pick-up with me, the following will apply:

1. I agree if I do not complete purchase and pick-up/payment of this sheep that I have reserved, within this time frame, or if I decide for any reason not to purchase the sheep, I will forfeit my full deposit and any payments made and the sheep will be available for purchase by another buyer.
2. With prior arrangement, if unable to pick the lamb/sheep up on the scheduled pick-up day due to transportation delays, or two-weeks from reservation/contract form date for older sheep, I am willing to pay a daily boarding fee of \$2.00 per day, per sheep. Sheep may be offered for resale two weeks after the pick-up date has passed.

Information on shipping/pick-up: Shipping costs or paperwork/tests required for shipping are not included in the price of the sheep, and the costs are the responsibility of the purchaser. The sheep and all fees that incur with shipment **MUST BE PAID IN FULL** prior to shipping with an animal transporter, or by air, two weeks in advance so all checks can clear before shipment. Lambs are shipped at 12 weeks or older. All shipping arrangements/shipping crates/fees will be the responsibility of the buyer. A \$150.00 airport delivery fee (Cincinnati/Northern Kentucky International Airport), if applicable; and, \$30.00 for a Certificate of Veterinary Inspection for Livestock (plus the cost of any additional tests that may be required depending on which state/country they are going to) will be added to the price of each sheep, along with any fees for crates required for shipment. I fully understand I have the opportunity to visit the farm to visually inspect said sheep, and I am accepting the sheep as is, if shipping via air or animal transport, without visiting.

Sheep leave the farm healthy and sound. Purchaser holds Bergamascos' Babydoll Brigade, LLC, and Michelle Schubert harmless for any injury or mishaps that may occur during transportation or for any injury, miscellaneous ailments, illness, death, and veterinarian fees after leaving Bergamascos' Babydoll Brigade, LLC, as proper care after purchase cannot be guaranteed. It is the purchaser's responsibility to gain the knowledge necessary to care properly for his or her sheep. Bergamascos' Babydoll Brigade, LLC will answer all questions regarding care to the best of their knowledge.

When you purchase a lamb/sheep **BRED** by Bergamascos' Babydoll Brigade:

- Your lamb/sheep was raised on a premise enrolled in the voluntary Scrapie Free Certification Program (SFCP) - Export Category.
- Additional health testing of my flock has been done such as Johne's & OPP. I have never had a case of CL nor soremouth/ORF in my flock.
- Your lamb/sheep's left ear will be tagged with a federally approved official Bergamascos' Babydoll Brigade SFCP Scrapie Tag.
- Your lamb/sheep's tail will be docked to a length of 2 to 3 inches.
- Your lamb/sheep's hooves will be trimmed.
- Your lamb/sheep's first CD/T vaccination and CD/T booster will have been administered.
- Your lamb/sheep will have a coefficient of inbreeding of $\leq 5.5\%$ for ≤ 10 generations of known ancestry (recommended is $\leq 12.5\%$) if bred by me.
- Certificate of Registration (CoR) for the NABSSAR will be supplied (excluding non-registered wethers). A CoR for the OEMBSSR will be provided, if lamb qualifies, for an additional \$15.00. If I have not received the CoRs back from the respective registries before pick-up day, a copy of the submitted applications will be provided to the buyer and the CoR will be mailed to buyer at a later date. Please note: This means the lambs are registered to me as the breeder. The buyers will be responsible for transferring their sheep into their names with the registry making them the new owner(s) of the sheep.
- You will receive an information packet.
- You will receive a bag of the brand of feed I have been using.
- You will be encouraged to contact me with any questions or concerns you may have.

This contract constitutes the entire understanding of the parties.
